## Membership Benefits Cottonwood Heights Figure Skating Club

Full Home-Club members of CHFSC enjoy all benefits (listed below). Associate Club members receive limited benefits (specifically noted for Associates below).

- **USFS membership:** Member of United Skates Figure Skating (USFS) through June 30, 2010.
- **Skating magazine:** Receive *Skating* monthly issues of magazine (one per household).
- **Test Sessions:** Eligible to take USFS figure skating tests, pay discounted Utah Interclub test fees and receive certificates, patches and recognition for tests passed; CHFSC will host test sessions during the '09-'10 season.
- **Competitions:** Eligible to compete in USFS sanctioned figure skating competitions. For the '09-10' season CHFSC will host Oktoberfest and Spring Fling.
- **Clinics:** Eligible to participate in skating and education clinics sponsored by CHFSC.
- **Show Performances/exhibitions:** Opportunity to participate in CHFSC shows, such as the annual Autumn Extravaganza, Holiday Ice Show, and Spring Show during the '09-'10 season. Participation rules for Associate Members are found in the CHFSC Standing Rules.
- **CHFSC Club Night:** Free ice time in accordance with the Club Night skater schedule. Participate in CHFSC Club Night activities, including our fall social, holiday parties, clinics, education sessions, spring banquet. Associate Club members may pay an additional fee to skate on Club Night Ice or to participate in Club events according to rules or criteria prescribed by the CHFSC Board.
- **CHFSC Communications:** Receive CHFSC newsletters and informational notices. Associate Club members are included in all communications.
- **CHFSC Photo and Directory:** Receive a CHFSC Club photo, have your picture posted on our bulletin board. Be included in and receive a CHFSC information directory. Associate Club members are included in and will receive a copy of the CHFSC member directory.
- **CHFSC Voting Privileges:** If over 18, vote on issues at the General Membership meetings.

## Volunteer Descriptions Cottonwood Heights Figure Skating Club

### **Leadership:**

**Board of Directors:** 5 to 10 hours per month and attend monthly meetings. Serve 2-3 years.

An interest in figure skating and a desire to improve the Club. Need email access.

**Event Chairperson, Registrar or Practice Ice:** 40-100 hours per event and 4-6 weeks prior to event. Serve 2-3 years.

Process applications; coordinate event in accordance with USFS and event rules. Adhere to budget.

**Jr. Board Member & Adult mentor:** 2-4 hours per month and attend monthly meetings Skaters ages 12 and up

Interested in improving the Club and learning valuable leadership skills. Adult mentor assists skaters with leadership roles.

Serve one year.

**Intermountain Interclub Representative:** 2 hours per month and attend meetings every other month. One of three Club delegates serving 2-3 years. A strong interest in fostering the development of Figure Skating in Utah

**Ice Monitor & Music:** 4 hour shifts during events or 2 hour shifts on Monday nights for Club. Enforce safety.

Check people in for the ice & play music during Club Night, Test Sessions, Competitions or Shows/Exhibitions.

**Events & Parties:** 3-10 hours per event Plan & coordinate Club Night parties and Ice Show Cast Party. Adhere to budget.

Create fun and encourage help from older skaters and Jr. Board Members.

**Judges Hospitality:** Food planning, preparation and presentation. Adhere to budget for Competitions (30 hours) and Test Sessions (10 hours).

**Runner** 4 hour shifts per event.(Competitions and Test Sessions) Collect judging sheets, take them to the accountants and post results; walk & climb stairs; suitable for skaters age 12 and up.

**Accounting Room** 4 hour shifts during Competitions. Assist Accountant with entering marks, using 10-key.

**Registration Desk** 4 hour shifts during Competitions. Check in skaters during competitions and collect music. Suitable for skaters age 12 and up to assist.

**Organize Vendors** 4 hours Solicit vendors for Oktoberfest, gather contracts, manage set up of vendor displays

**Announcer** 2 hours during Club Events Announce skaters, read prepared announcements

**Run Spotlight** 2 hours during Exhibitions and Ice Show rehearsal and show nights, training provided.

**Awards** 4 hour shifts at Oktoberfest and Spring Fling. Pass out medals and trophies.

**Ticket Sales** 2 hour shifts each night of the Ice Show. Collect & sell Tickets & Programs during event.

**Room Monitor** 3 hours during rehearsal and Ice Show; 2 adults per dressing room. Assist skaters in dressing room with costume changes, lacing skates, during show nights—make sure skaters are prepared for their numbers. Maintain order and safety for skaters in the dressing rooms.

**Gifts for Skaters & Judges** 10 hours per Competition Solicit donations for thank you gifts for judges and prepare goody bags for competitors.

**Fundraisers & Boutiques** 10-20 hours per year. Solicit donations for CHRC Golf Tournament, silent auctions and boutiques, imagine and organize fun and entertaining fundraising events.

**Costumes & Staging** 10 to 50 hours in advance of the Ice Show. Plan & coordinate for the purchase and/or creation of costumes and props/staging for ice shows. Creativity to work with limited budgets essential.

**Prepare Program** 20 to 40 hours in advance of event (Ice Show or Competitions) Responsible for creating program and meeting publication deadlines. Familiarity with desk top publishing helpful.

**Volunteer Coordinator** 10-20 hours per event (Oktoberfest, Ice Show, Exhibitions, Parties). Find volunteers and assign time slots. Most can be done by phone.

**PR, News, Advertising** 10 to 50 hours per year. Develop relationships and contacts to promote Club events and activities in newspapers, magazines, schools. Create announcements, banners, promotional literature.

**Education, Bulletin Board** 10 hours per year. 1 hour shifts at least 9 times a year to attend Club education booth at the end of each Learn to Skate session. Maintain Club bulletin board.

**Newsletter** 5-7 hours per month. Write, edit, publish and email monthly newsletter. Maintain calendar of events, contribute photos, skater news, feature articles and education.

**Membership Directory** 4 hours Update Membership Directory using established format in Word and arrange for printing and distribution in January. Attention to detail is required.

**Photo DVD** 5 to 20 hours per month Take photos at Club events, create DVD copies for each member, provide photos & pages for Club scrap book, and displays. Digital camera required. Older skaters may assist.

**Website** 2-10 hours per month Create, design, update, maintain Club web site
